#### <u>SUMMARY</u>

Council to consider the monthly financial report for the period ending 31 July 2019.

#### BACKGROUND

The Local Government (Financial Management) Regulations 1996 require a statement of financial activity to be prepared each month and prescribe the contents of that report and accompanying documents. The report is to be presented at an ordinary meeting of the Council within 2 months after the end of the month to which the report relates.

Each financial year, Council is required to adopt a percentage or value to be used in the statement of financial activity for reporting material variances.

As part of the 2018/19 budget process, Council adopted 10% or \$10,000 as the material variance for reporting purposes for the year.

#### **COMMENT**

The financial report presented is an interim financial report for Councillors information and shows revenue and expenditure incurred in the first month of the new financial year. Budget comparatives are not yet included, as the Annual Budget for 2019/20 was not adopted prior to the end of July.

A financial report compliant with the requirements of the *Financial Management Regulations* will be presented for adoption at the September 2019 meeting.

#### **SUMMARY**

For Council to consider a request to amend the Restricted Access Vehicle (RAV) rating for North Stirling, Stirling Access, Beejenup, Yetemerup and White Roads.

#### BACKGROUND

An application was submitted to Main Roads Western Australia (MRWA) requesting local access at RAV 7 for North Stirling, Stirling Access, Beejenup, Yetemerup and White Roads.

North Stirling Road is the continuation of Toolbrunup Road, starting at the Stirling Access Road intersection and continuing over the boundary into the Gnowangerup Shire where it is rated RAV 7.

White Road begins at Toolbrunup Road and then continues as Yetemerup Rod as it crosses Stirling Access Road going into the Cranbrook Shire.

Stirling Access Road is the linking road continuing from Beejenup Road ending at the Toolbrunup Road and North Stirling Road intersection

North Stirling Road, Yetemerup Road and White Road are all currently rated to accommodate RAV 6 vehicles.

The proposed length of Beejenup Road is located in the section of the road currently rated to accommodate RAV 2 vehicles.

Stirling Access is currently rated to accommodate RAV 2 vehicles.

#### **COMMENT**

The Technical Officer has inspected the five roads. There are no changes in road conditions from Beejenup Road to Stirling Access, White Road to Yetemerup and from Toolbrunup Road to North Stirling Road.

North Stirling Road within the Gnowangerup Shire is rated a RAV 7 Network road. Yetemerup Road within the Cranbrook Shire is rated a RAV 7 Network road.

All roads are well constructed and well maintained.

Only North Stirling Road is used by the School Bus Services

All roads are constructed with gravel pavement.

It is recommended that North Stirling Road, Stirling Access Road, Beejenup Road, Yetemerup Road and White Road be amended to RAV Network 7 subject to the following conditions:

• Direct radio contact must be maintained with other RAV's to establish their position on or near the road (suggested UHF channel 40).
