5.2 RISK REVIEW – RISK TREATMENTS REGISTER

In 2017 and 2018 the Shire of Broomehill-Tambellup undertook a risk assessment of hazards likely to impact within the Shire. This included the hazards of.

- Fire (bushfire)
- Heatwave
- Hazardous Materials; and
- Flood

The risk assessment process analysed 194 risk statements across the four hazards. From these risk statements, 75 risks were identified as requiring treatments and 31 required to be considered for treating.

The LEMC has commenced the process of workshopping each risk area, to identify possible treatments. These have been collated into a register which will be updated following each workshop.

The register will be included in LEMC agendas as a standard item, to monitor progress towards implementation of strategies. Agencies should note actions assigned.

6. AGENCY UPDATES

Cindy Pearce – Community Emergency Services Manager

- Preparing for the coming fire season: brigade meetings, updating Standard Operating Procedures, training (Rural Fire Awareness 29 August 2023, Fire Control Officer 12 September 2023)
- Earthquake occurred on 6 August damage to infrastructure east of Gnowangerup
- Successful application to ESL has resulted in funding for a new fast fill trailer for Broomehill West brigade.
- Flat Rocks Wind Farm need to check tank outlet size for compatibility with brigade equipment.

Jodie Pollard – Department of Communities

• Will be completing reviews of the Welfare Plan and inspections of the evacuation centres.

Cindy Veitch – Tambellup Primary School

• Stand Alone Bushfire Plan to be submitted by the end of August, will be presented to the LEMC for information at the next meeting.

Pam Hull – for Tambellup Volunteer Fire & Emergency Services

• Upgrade works are in progress at the Fire Shed to construct a tunic room with appropriate ventilation, and new ablutions. Due to be completed mid-October.

David Swain - Tambellup Police

- Staffing in Tambellup and Cranbrook is stable, a new OIC and Constable to be appointed in Gnowangerup.
- Two searches conducted in the Stirlings a seven day response at Mt Magog, and an extraction of Ellen Peak.
- Access to new Police air assets will improve response to searches in the Stirlings, being able to fly from Perth to the Stirlings, do an initial search of the area and then to Albany to refuel.
- With harvest season approaching local police will be conduction highway patrols in conjunction with Heavy Vehicle Services, aiming to reduce the number of road train rollover incidents.

Stephanie Swain – Ranger Services

• Will prepare education resources relevant to fire season preparedness for landowners, for Topics and social media.

Andrew Ferres – Flat Rocks Wind Farm

- Noted that activity leading into the fire season last year was civil works, this year
 works are centred on construction and craning components into position, and
 subsequently a lesser fire risk. Less people will be onsite, however there is still a
 need for fire awareness training to be completed.
- Cr White queried the firefighting water capacity on site, noting the Council has requested a minimum of 3000lt firefighting appliance to be available. Andrew Ferres advised the site has 4 x 1000lt tanks on site, and would need a water tanker and vehicle to tow for 3000lt. Cr White advised this does not necessary have to be a towed tanker.
- David Swain queried the arrangements for bushfire management by contractors working on the CBH expansion in Broomehill. Cindy Pearce to follow up.

7. GENERAL BUSINESS

Evacuation Centres: With regard to the review of evacuation centres, Anthony queried the practicality of the existing arrangements (Tambellup Community Pavilion, Broomehill Recreational Complex noted as primary evacuation centres). Neither of the facilities are adequate for extended evacuations through not having the space required to effectively separate for various cultural, medical or other reasons. The ability to source basic supplies is non-existent in Broomehill and limited in Tambellup. Would it be better to consider the use of regional evacuation centres in Katanning, Mt Barker or Albany as primary evacuation centres?

Jodie advised the review of the Local Welfare Plan will consider the appropriateness of the facilities, and also the availability of supplies and review of supplier contacts.

Michael queried whether there was a role for the local facilities as short term evacuation centres.

David noted there is the likelihood that an incident may impact both towns, requiring residents to evacuate outside the area.

Cindy Pearce noted the Katanning Leisure Centre has space for separation if required, and a generator to power all areas including the oval lights.

Anthony queried whether neighbouring local governments should contribute to key regional facility upgrades such as the installation of the generator in Katanning.

It was noted the Shires of Katanning, Woodanilling and Kent have a combined LEMC – should Shire BT attend neighbouring LEMCs, or should we be considering joint LEMCs with neighbouring Shires. This would be beneficial in understanding who the regional stakeholders are. To be considered further.

Training Exercise: David Swain suggested conducting a land search desktop exercise, to involve the Shires surrounding the Stirling Range – i.e. Shire of Broomehill-Tambellup, Cranbrook, Gnowangerup and Plantagenet. This could potentially include a demonstration of the drone technology that is used by WAPOL. All present agreed that this would be a valuable exercise. David will initiate planning and more information will be provided.

8. NEXT MEETING AND CLOSE

The next meeting is scheduled for November 2023, with the date to be confirmed. There being no further business, Cr White thanked everyone for their attendance and declared the meeting closed at 10.30am.
